Sub: Abkari – Request for destruction of dead stock of liquor ascertained in the stock taking held on 31.03.2019 and lying at KSBC FL1 shops and FL9 Warehouses – Sanctioned - Orders Issued.

The Managing Director, Kerala State Beverages Corporation, Thiruvananthapuram vide letter read above has reported that in the stock taking conducted at the FL-9 Warehouses and FL-1 Retail Shops of the Corporation on 31.03.2019, the following stocks were identified as having become dead during the period of 2018-2019.

- At the KSBC FL-9 Warehouses 52262 cases and 4183 bottels (IMFL 7034 cases and 2753 bottles+ Beer 45228 cases and 1430 bottles)
- At the KSBC FL-1 Retail Shops 471062 bottles (IMFL 190607 bottles+Beer 280455 bottles).(details annexed)

Kerala State Beverages Corporation vide letter read above has reported that the cost, Excise Duty and Import fee on the above sedimented /dead liquor stocks have already been debited from the payment due to the respective liquor suppliers and therefore there is no financial or revenue loss to the Corporation or the State exchequer. Hence he requested to give sanction for destroying the liquor stock.

In the above circumstances, sanction is hereby accorded to destroy the dead stocks mentioned in the letter read above at the Effluent Treatment Plant at TSCL, Thiruvalla in the presence of Assistant Excise Commissioner, Pathanamthitta without any financial loss to Government. Assistant Excise Commissioner, Pathanamthitta will ensure that there is no pollution to the environment due to the destruction and should avoid any cause of misuse while destroying the liquor stock. The liquor stock should be destroyed after preparing Mahazar and it should be ensure that the stock of liquor received at TSCL is tallying with that dispatched from the respective KSBC FL1 shops and FL9 Warehouses.
