l xpianation: For the purpose of this notification, case means 48 bottles of 180ml each or 24 bottles of 375 ml each or 18 bottles of 500 ml each or 12 bottles of 750 ml each or 9 bottles of 1000 ml each of Foreign Liquor or 24 bottles of 330 ml each or 24 cans of 500 ml each or 12 bottles of 650 ml each of beer.

xplanatory ote

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the existing notification and circulars, No Objection Cetificate (NOC) and permits are issued for a particular quantity of liquor fixed by the Government or Excise Commissioner as the case may be. Issue of more than one Non Objection Certificate or permit to a single consignment causes processing hurdles to the licensees. In order to avoid the above hurdles and to protect Government revenue, Government have decided to fix the fee on the Non Objection Certificate and permits issued under sections 6, 7 and 11 of Abkari Act, (1 of 1077) on the basis of the quantity covered under each permit. For this purpose it has been decided to issue notification fixing the rate of Non Objection Certificate and permits and quantity of liquor covered in each permit in supersession of the notification issued under G.O. (P) No. 145/2018/TD dated 12th September, 2018.

This notification is intended to achieve the above object.
