In exercise of the powers conferred by section 29 of the Abkari Act 1 of 1077, the Government of Kerala hereby make the following rules further to amend the Kerala Spirituous Preparations (Control) Rules, 1969 issued by notification published as S.R.O. No. 72/69 dated 13th February, 1969, in the Kerala Gazette Extraordinary No. 46 dated 18th February, 1969, namely:—



RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Spirituous Preparations (Control) Amendment Rules, 2021.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Kerala Spirituous Preparations (Control) Rules, 1969, in sub-clause (ii) of clause (a) of sub-rule (1) of rule 11, after the words “registered medical practitioner or,” the words, figures and symbol “to the dealers of the manufacturers under the Indigenous system of medicine having manufacturing licence under the Drugs and Cosmetics Act, 1940 (Central Act 23 of 1940) or” shall be inserted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have decided to grant S.P.VI licence under the Kerala Spirituous Preparations (Control) Rules, 1969 to the dealers of the manufactures under the Indigenous System of Medicine having manufacturing licence under the Drugs and Cosmetics Act, 1940 (Central Act 23 of 1940). In order to give statutory effect to the above decision, Government have decided to amend the Kerala Spirituous Preparations (Control) Rules, 1969 issued by notification published as S.R.O. No. 72/69 dated 13th February, 1969 in the Kerala Gazette Extraordinary Number 46 dated 18th February, 1969.

The notification is indented to achieve the above object.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have decided to increase the period of the licenses granted under the Kerala Spirituous Preparations (Control) Rules, 1969 to three years from the existing one financial year as part of ease of doing business. To implement the above decision, the Kerala Spirituous Preparations (Control) Rules, 1969 needs to be amended suitably.

The notification is intended to achieve the above object.
