1. PRE QUALIFICATION CRITERIA

- a. Firms who have been blacklisted by the Central Government/ any State Government will not be considered
- b. Bidders should remit the required Tender Fee and Earnest Money Deposit (EMD) in 'Online mode' through SBI/NEFT, as per 1(e) and I(f) of the Notice Inviting Tender. No exemption in the case of EMD and Tender Fee. Bidders should ensure and convince themselves that the online payments made by them have been successfully transferred. Excise Department shall under no circumstances be responsible for failed transaction of the payments due to non- compliance of any online banking procedure and consequent rejection of tender.
- c. This Notice Inviting Tender (all pages) duly filled ,signed and stamped by the bidder should be scanned and uploaded.
- d. Copy of valid manufacturing license in the case of manufacturer. In the case of dealer, they should upload the scanned copy of valid Dealership certificate.
- e. The details of Guarantee/Make / Brand / specification of offered item / Brochure etc should be uploaded.
- f. ANNEXURE A after filling all the column duly signed and stamped by the bidder should be uploaded.
- g. **SAMPLE:-** (Compulsory)

Bidders should submit one piece as sample to the Excise Commissioner, Excise Head Quartes, Nandavanam, Vikas Bhavan Po 695033 on or before the due date and time of tender opening. No sample shall be returned by the department

The sample submitted by the bidders will be inspected / tested for assessing its suitability and conformity to the tender specifications. If the samples do not meet the specifications of tender, the bidder will be technically disqualified.

Note:- Those bidders who do not successfully remit Tender fee and EMD online or do not upload the above mentioned document (digitally signed)

will be rejected. The bidders should possess digital signature for

uploading the documents.

2. Instructions for submitting Financial bid:-

- a. The bidders should furnish the basic rate for the item, discounts, GST, other charges separately. The rates shall be submitted in BOQ portion of the corresponding Tender published in website www.etenders.kerala.gov.in.
- b. The rate quoted should be for delivery to 14 Division Offices
- c. The rates shall be submitted in **BOQ/PRICE BID link** available in the etender portal available in www.e-tender.kerala.gov.in.
- d. All the Charges should be calculated exactly and entered in the respective column of BOQ.
- e. If the amounts of levies such as GST etc. are not entered in the respective column of BOQ, such bidders will not be eligible for revised levies declared from time to time.
- <u>Selection of suppliers</u>: The selection of suppliers will be made from among the technically qualified bidders who are prequalified by uploading all the mandatory documents mentioned in the prequalification criteria. The department will place order with the L1 qualified bidder.
- <u>Opening of Financial Bid:</u> The BOQ/PRICE Bid of those bidders, who satisfied all of the **Pre-qualification Criteria** shall only be opened for further consideration. The BOQ/PRICE BID of those bidders who do not satisfy even any one of the pre-qualification condition will not be opened.
- Tenders uploaded after the due date and time fixed in the e- tender portal will not be considered.
- Opening of Tender will be done at the time and date mentioned in the etender portal at the Office of the Excise Commissioner, Excise Head quarters, Nandavanam
- The details such as name of manufacturer, make/brand etc. should be provided in the tender.
- <u>Payment:</u> Payment for the material will be made only after receipt, inspection and acceptance of the supplied items at the destination specified by The Excise Department
- <u>Liquidated damages for non supply and performance:</u> The successful bidders shall supply the ordered quantity of materials as per the delivery schedule given by the Excise Department. If materials are not supplied as per supply schedule given by the Excise Department, liquidated damages will be realized from the supplier at the rate of 0.5% of the Cost of item per week for each week or part thereof, up to a maximum deduction of 10% of the contract prices and there after the department will consider the termination of the contract at the risk and cost of the contractor.

Earnest Money Deposit:- The EMD will not carry any interest .The EMD will be forfeited if the successful Bidders fail to execute agreement and furnish

Security deposit, or in the event of withdrawal of offer once made or in the event of putting forth any conditions which are against or contradictory to the conditions of this Notice Inviting Tender.

Security Deposit: - The successful Bidder has to furnish a Security Deposit equivalent to 5% of the total value of purchase contract awarded to them, before executing the agreement. *The security deposit carries no interest*. The EMD amount will be adjusted in the security deposit in the case of successful bidders. The Security Deposit can be remitted either in the form of Demand Draft from any Nationalized/Scheduled Bank drawn in favor of Excise Commissioner or in the form of Bank Guarantee from any Nationalized/Scheduled Bank with a claim period of minimum 3 months beyond the expiry of the contract including warranty period. The security deposit will be forfeited if the contractor fails to complete the supply as per the schedule issued by the Excise Department or in the event the Bidder fails to settle any claim including the warranty claims. The security deposit will be refunded only after the satisfactory completion of the contract including warranty claims or penalty settlement.

Agreement:- The successful Tenderer shall have to execute an agreement within 10 days from the date of issue or purchase order, incorporating the Terms & Conditions of Tender and as per Kerala Stores Purchase Manual. The agreement has to executed in the prescribed form issued from Excise department, in Rs.200/- INDIAN STAMP PAPER after furnishing the Security deposit equivalent to 5% of the total value of purchase contract awarded to them, as per provisions of Kerala Store Purchase Manual, for the due fulfillment of the contract. If the bidders are not willing to execute the Agreement and Security deposit, their offer will not be considered.

The bidders have the liberty to resubmit fresh tender/documents till the last date and time of submission of the e-tender.

Re submission of offer will not be allowed after the time and date fixed for bid submission. The offer once made cannot be withdrawn or modified after the closing of e-tender under any circumstances. Withdrawal or modification of the offer once made in e-tender will be resulted in the forfeiture of EMD remitted. In such cases the bidder will not have the right to claim the refund of EMD.Bidders should be able to start delivery of materials within 10 days from the date of order. Supply of the materials should be completed within the time stipulated by the Excise .I S I specification, if any, is to be noted clearly. Details of Warranty if any offered by the supplier should be specified clearly. Reference of previous supply if any is to be noted clearly. 20. The Excise Commissioner reserve the right to make any modifications or additions in this notice

The decisions of the Excise Commissioner will be final and legally binding in these tender proceedings.
