In exercise of the powers conferred by sections 24 and 29 of the Abkari Act 1 of 1077, the Government of Kerala hereby make the following rules further to amend the Kerala Foreign Liquor (Compounding, Blending and Bottling) Rules, 1975 issued by notification under G.O. (P) No. 134/75/TD dated 4th October, 1975 and published as S.R.O. No. 902/75 in the Kerala Gazette Extraordinary No. 583 dated 4th October, 1975, namely:—



RULES

2

1. *Short title and commencement.*—(1) These rules may be called the Kerala Foreign Liquor (Compounding, Blending and Bottling) Amendment Rules, 2023.

(2) They shall come into force at once.

2. Amendment of the Rules.—In the Kerala Foreign Liquor (Compounding, Blending and Bottling) Rules, 1975, in rule 9, after sub-rule (12), the following sub-rule shall be inserted, namely:—

"(13) Excise Commissioner may allow export of Indian Made Foreign Liquor in bulk of any strength in receptacles either under bond or after payment of duty on production of the documents regarding the request of the importer to any State in India or to any place outside India on following conditions, namely:—

(i) The export of Indian Made Foreign Liquor shall be done on the strength of export permit issued by the Excise Commissioner;

(ii) The export of Indian Made Foreign Liquor shall be done in any clean receptacles of any quantity that can be effectively closed and sealed. The receptacles shall be of any material in which liquor can be stored securely:

Provided that the receptacles shall be of food grade and satisfies the Food Safety and Standards Authority of India standards as per the Food Safety and Standards (Packaging) Regulations, 2018.

(iii) Label shall be affixed on the receptacles with the description, quantity and strength of the Indian Made Foreign Liquor, the name of manufacturer, place and date of manufacture. In the case of export by sea, air or through land, the advice shall be sent to the concerned officer at the respective port/airport/land as the case may be.

(iv) Notwithstanding anything contained in these rule or any notification issued by the Government in this regard rupees Two per proof litre shall be collected as export fee."
