In exercise of the powers conferred by section 18A of the Abkari Act, I of 1077, read with sub-rule (1) of rules 3, 4, 5, 5.O and sub-rule (26) of rule 7 of the Kerala Abkari Shops Disposal Rules, 2002, the Government of Kerala hereby make the following amendment in the notification issued under G. O. (P) No. 115/2023/TAXES dated 4th September, 2023 and published as S. R. O. No. 942/2023 in the Kerala Gazette Extraordinary No. 2889 dated 5th September, 2023, namely:—



#### **AMENDMENT**

In the said notification, in the second paragraph, in the first sentence, for the figures, letters, word and symbol "13th September, 2023", the figures, letters, word and symbol "16th September, 2023" shall be substituted.

#### **Explanatory Note**

(This does not form part of notification, but is intended to indicate its general purport.)

As per notification issued under G. O. (P) No. 71/2023/Taxes, dated 6th June, 2023 and published as S. R. O. No. 654/2023 in the Kerala Gazette Extraordinary No. 1951 dated 9th June, 2023, the Government have amended the Kerala Abkari Shops Disposal Rules, 2002 for conducting sale of Toddy Shops through online platform. Government as per notification issued under G. O. (P) No. 115/2023/TAXES dated 4th September, 2023 and published as S. R. O. No. 942/2023 in the Kerala Gazette Extraordinary No. 2889 dated 5th September, 2023, have notified schedule of sale of Toddy Shops on online platform in the State for the financial years 2023-2024, 2024-2025, 2025-2026. As per the notification, the last date of submission of application for participating in the sale of such shops was 13th September, 2023. Several applicants have requested for extension of time, as they encountered delay in getting certificates from Police, Revenue, Welfare Fund Board etc. Hence the Government have decided to extend the last date for submission of application from 13th September to 16th September, 2023 and to amend the above said notification suitably.

The notification is intended to achieve the above object.
