S. R. O. No. 629/2018.—In exercise of the powers conferred under section 24 of the Abkari Act, 1 of 1077, and in supersession of the notification issued under G. O. (P) No. 212/2009/TD. dated 30th November, 2009 and published as S. R. O. No. 1023/2009 in the Kerala Gazette Extraordinary No. 2231 dated 30th November, 2009 the Government of Kerala hereby direct that a fee of ₹ 2,000 (Rupees two thousand only) shall be levied on each permit for a maximum quantity of 25000 Bulk Litre to be issued under sections 6 and 7 of the said Act, a fee of ₹ 1,500 (Rupees one thousand five hundred only) shall be levied on each permit to be issued under section 11 of the said Act and

₹ 2,000 (Rupees two thousand only) on each No Objection Certificate to be issued under sections 6 and 7 of the said Act to all licensees under the Kerala Distillery and Warehouse Rules, 1968, the Kerala Foreign Liquor (Compounding, Blending and Bottling) Rules, 1975, the Brewery Rules, 1967, the Kerala Winery Rules, 1970, the Kerala Rectified Spirit Rules, 1972 and the Foreign Liquor Rules for the purpose of importing, exporting or transporting any kind of liquor and rectified spirit including absolute alcohol.

The notification shall come into force at once.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government find it necessary to enhance the fee from ₹ 1,000 (Rupees one thousand only) to ₹ 2,000 (Rupees two thousand only) on each No Objection Certificate to be issued under sections 6 and 7 of the Abkari Act 1 of 1077 along with enhancing the fee from ₹ 1.000 (Rupees one thousand only) to ₹ 2,000 (Rupees two thousand only) on each permit to be issued up to the quantity of 25000 Bulk Litre under sections 6 and 7 and enhancing the fee from ₹ 500 (Rupees five hundred only) to ₹ 1,500 (Rupees one thousand five hundred only) on each permit to issued under section 11 of the Abkari Act 1 of 1077 to all licences issued under Kerala Distillery and Warehouse Rules, 1968, the Kerala Foreign Liquor (Compounding, Blending and Bottling) Rules, 1975, the Brewery Rules, 1967, the Kerala Winery Rules, 1970, the Kerala Rectified Spirit Rules, 1972 and the Foreign Liquor Rules for the purpose of importing, exporting or transporting liquor and rectified spirit including absolute alcohol by those licensees. For this purpose it has been decided to issue a notification in supersession of the notification issued under G. O. (P) No. 212/2009/TD. dated 30th November, 2009 and published as S. R. O. No. 1023/2009 in the Kerala Gazette Extraordinary No. 2231 dated 30th November, 2009.

The notification is intended to achieve the above object.
