S. R. O. No. 58/2016.—In exercise of the powers conferred by section 18 A of the Abkari Act 1 of 1077, read with sub-rule (1) of rule 3 and rule 4 of the Kerala Abkari Shops Disposal Rules, 2002 and all other powers vested in Government in this regard, the Government of Kerala hereby make the following further amendments to the notification issued under G. O.(P) No. 58/2008/TD, dated 19th March, 2008 and published as S. R. O. No. 291/2008 in the Kerala Gazette No. 558 dated 19th March, 2008, namely:—

AMENDMENT

In the Schedule to the said notification, in the Appendix, under the heading “7. എറണാകുളം ഡിവിഷൻ”, under sub heading “കുന്നത്തുനാട് താലൂക്ക്-മാമല റേഞ്ച് കളക്ട്.”

(i) against shop number 16, for the entries in column 4, the following entries shall be substituted, namely:—

“വടക്ക്—അമ്പലംപടി-ചാവുപിറപ്പടി റോഡ്.

കിഴക്ക്—കൊടിയീലക്കുന്ന് താഴത്തെ റോഡ്.

തെക്ക്—വീല്ലേഴ് അതിർത്തി.

പടിഞ്ഞാറ്—വീല്ലേഴ് അതിർത്തി”;

(ii) against shop number 51, for the entries in column 4, the following entries shall be substituted, namely:—

“വടക്ക്—ഐക്കരനാട് വീല്ലേഴ് അതിർത്തി.

കിഴക്ക്—പുളിഞ്ചോട്-പട്ടിമറ്റം റോഡ്.

തെക്ക്—അമ്പലംപടി-ചാവുപിറപ്പടി റോഡ്.

പടിഞ്ഞാറ്—വീല്ലേഴ് അതിർത്തി.”

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the notification issued under G. O. (P) No. 58/2008/TD, dated 19th March, 2008 and published as S. R. O. No. 291/2008 in the Kerala Gazette No. 558 dated 19th March, 2008, the Government have notified the number of independent toddy shops in each range and the limits within which the shops are to be located. The licensee of Toddy shop number 16 of Mamala Range in Kunnathunad Taluk of Ernakulam Division could not find suitable place in the scheduled limit for functioning the shop. The Excise Commissioner has recommended to reschedule the limits of Toddy shop numbers 16 and 51 so as to enable the licensee to function the Toddy shop number 16. Hence Government have decided to change the schedule limit of the above toddy shops for the smooth functioning of the both toddy shops.

The notification is intended to achieve the above object.
