S. R. O. No. 597/2014.—In exercise of the powers conferred by sections, 18A, 24 and 29 of the Abkari Act, 1 of 1077, the Government of Kerala hereby make the following rules further to amend the Foreign Liquor Rules issued under notification No. SR 4-1859/52/RD dated 17th January, 1953 and published in the Travancore-Cochin Gazette Extraordinary No. 2 dated 17th January, 1953, namely:—

RULES

- Short title and commencement.**—(1) These rules may be called the Foreign Liquor (5th Amendment) Rules, 2014.
(2) They shall come into force at once.

2. Amendment of the Rules.—In the Foreign Liquor Rules,—

(1) in rule 28A, after item (ix), the following item shall be added, namely:—

“(x) All Sundays.”

(2) in FORM FL1, under the heading “CONDITIONS”, in condition No. 16, after item (ix), the following item shall be added, namely:—

“(x) All Sundays.”

(3) in FORM FL3, under the heading “CONDITIONS”, in condition No. 20A, after item (ix), the following item shall be added, namely:—

“(x) All Sundays.”

(4) in FORM FL4, under the heading “CONDITIONS”, in condition No. 2A, after item (ix), the following item shall be added, namely:—

“(x) All Sundays.”

(5) in FORM FL4A, under the heading “CONDITIONS”, in condition No. 18, after item (ix), the following item shall be added, namely:—

“(x) All Sundays.”

(6) in FORM FL11, under the heading “CONDITIONS”, in condition No. 9, after item (ix), the following item shall be added, namely:—

“(x) All Sundays.”

(7) in FORM FL12, under the heading “CONDITIONS”, in condition No. 9, after item (ix), the following item shall be added, namely:—

“(x) All Sundays.”

(8) in FORM FL13, under the heading “CONDITIONS”, in condition No. 8, after item (ix), the following item shall be added, namely:—

“(x) All Sundays.”

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

In the Abkari Policy announced for the year 2014-15, vide G.O. (Ms.) No. 139/14/TD dated 22nd August, 2014, the Government have decided to declare “All Sundays” as Dry Days from 5th day of October, 2014. In order to give statutory validity to the above said decision the Foreign Liquor Rules needs to be amended suitably.

The notification is intended to achieve the above object.
