#### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per sub-rule (2) of rule 3 of the Kerala Abkari Shops Disposal Rules, 2002, the annual rental of Foreign Liquor-1 Shops has to be fixed each year. Now the Government have decided to fix the annual rental of each Foreign Liquor-1 Shops for the year 2017-18 as ₹ 3,00,000 (Rupees Three Lakhs only).
