S. R. O. No. 352/2018.—In exercise of the powers conferred by sections 14, 24 and 29 of the Abkari Act, 1 of 1077, the Government of Kerala hereby make the following rules further to amend the Foreign Liquor (Storage in Bond) Rules, 1961 issued under G. O. (Ms.) 1041/61/RD dated 12th December, 1961 and published in the Kerala Gazette dated 2nd January, 1962, namely:—

RULES

- 1. Short title and commencement.—(1) These rules may be called the Foreign Liquor (Storage in Bond) Amendment Rules, 2018.
 - (2) They shall come into force at once.

- 2. Amendment of the Rules.—In the Foreign Liquor (Storage in Bond) Rules, 1961,—
 - (1) for rule 14, the following rule shall be substituted, namely:—
- "14. A licence in Form BW1 shall be granted to the Kerala State Beverages (Manufacturing and Marketing) Corporation Limited and a licence in Form BW1(A) shall be granted to the Canteen Stores Department, Ministry of Defence and Central Police Canteen, Ministry of Home Affairs, Government of India for the purpose of Storage in Bond and supply of Foreign Liquor including beer in wholesale to the FL8 and FL8A licensees and FL9 licensees respectively under the Foreign Liquor Rules.";
- (2) in FORM BW1(A), for the letters, figure and symbols, "F.L.8" wherever they occur the word, letters, figures and symbols "F.L.8 and FL.8A" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (Ms.) No. 93/2017/TD dated 3rd November, 2017 and G. O. (Ms.) No. 22/2018/TD dated 16th March, 2018, the Government have decided to grant BW1(A) licence to the Central Police Canteen also. The Foreign Liquor (Storage in Bond) Rules, 1961 needs to be amended suitably for implementing the above decision.

The notification is intended to achieve the above object.
