S. R. O. No. 701/2017.—In exercise of the powers conferred by clause (d) of section 4 of the Abkari Act, 1 of 1077 and of all other powers hereunto enabling and in partial modification of the notification issued under G. O. (P) No. 420/2009/TD dated 8th May, 2009 and published as S.R.O. No. 361/2009 in the Kerala Gazette Extraordinary No. 833 dated 8th May, 2009, the Government of Kerala hereby appoint the officers of the Excise Range Office, Chittar, to register all the cases

detected by the officers of the temporary Excise Range Offices at Nilackal, Pampa and Sabarimala (Sannidhanam) opened during the Sabarimala Pilgrimage Season in so far as they relate to the area of jurisdiction of Ranni and Chittar Excise Range Offices, for the purpose of the administration of the said Act and the Narcotic Drugs and Psychotropic Substances Act, 1985 (Central Act 61 of 1985).

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

For the purpose of the administration of Abkari Act, 1 of 1077 and the Narcotic Drugs and Psychotropic Substances Act, 1985 (Central Act 61 of 1985), the Government of Kerala open temporary Excise Range Offices at Nilackal, Pampa and Sabarimala (Sannidhanam) during every Sabarimala Pilgrimage Season to conduct intensive drive against the transportation and consumption of liquor or any other intoxicating drugs and against the violations of the said Acts.

The Government of Kerala consider that it is necessary to appoint the officers of the Excise Range Office, Chittar to register the cases which are detected by the officers of the temporary Excise Range Offices at Nilackal, Pampa and Sabarimala (Sannidhanam) opened during the Sabarimala Pilgrimage season.

The notification is intended to achieve the above object.
