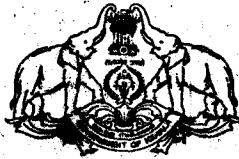

No. 188/2015.—In exercise of the powers conferred by section 18A of the Abkari Act, 1 of 1977, read with sub-rule (2) of rule 3 of the Kerala Abkari Shops Disposal Rules, 2002, the Government of Kerala, hereby notify that, the annual rental of Foreign Liquor-1 Shops specified in column (3) of the Schedule to the notification issued under G.O. (P) No. 66/2008/TD dated 27th March, 2008 and published as S.R.O. No. 322/2008 in the Kerala Gazette Extraordinary No. 617 dated 27th March, 2008 shall be ₹ 3,00,000 (Rupees Three Lakhs only) each for the year 2015-16.

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per sub-rule (2) of Rule 3 of the Kerala Abkari Shops Disposal Rules, 2002, the annual rental of Foreign Liquor-1 Shops have to be fixed each year. The Government have decided to reduce the annual rental of Foreign Liquor-1 Shops from ₹ 63,00,000 to ₹ 3,00,000 for the year 2015-16, vide G.O.(Ms.) No. 113/2014/TD dated 15th July, 2014.

The notification is intended to achieve the above object.
