NOTIFICATION

G. O. (Ms.) No. 205/2012/TD. Dated, Thiruvananthapuram, 17th October, 2012.

S. R. O. No. 735/2012.—In exercise of the powers conferred by section 9 of the Abkari Act 1 of 1977, the Government of Kerala hereby prohibit the transportation of liquor or intoxicating drugs of any kind from any local area to the local areas specified in column (4) of the Schedule annexed hereto;

And, for the purpose of the administration of Abkari Act 1 of 1977, the Narcotic Drugs and Psychotropic Substances Act, 1985 (Central Act 61 of 1985) and the Medicinal and Toilet Preparation (Excise Duties) Act, 1955 (Central Act 16 of 1955) and in modification of notification, issued under G. O. (Ms.) No. 65/07/TD., dated 29th March, 2007 and published in the Kerala Gazette

Extraordinary No. 619 dated 29th March, 2007, as subsequently modified in so far as it relates to the area of jurisdiction of Kanjirappally, Ranni and Chittar Excise Range Offices, the Government of Kerala hereby declare that the building allotted by the Travancore Devaswom Board at Erumeli in Kanjirappally Taluk and Nilackal, Pamba and Sabarimala (Sannidhanam) of Ranni Taluk shall be Excise Range Offices known as Erumeli, Nilackal, Pamba and Sabarimala (Sannidhanam) Range Offices respectively, with jurisdiction over the local areas specified in column (4) of the Schedule annexed hereto:—

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government consider it necessary to open temporary Excise Range Offices at Erumeli, Nilackal, Pamba and Sabarimala (Sannidhanam) during the current Sabarimala Pilgrimage Season and to conduct intensive drive against consumption of liquor or any other intoxicating drugs and violation of Medicinal and Toilet Preparations Rules in these areas.

The notification is intended to achieve the above object.
