## PART III Notifications by Heads of Departments Commissionerate of Excise

PROCEEDINGS OF THE COMMISSIONER OF EXCISE, KERALA  
THIRUVANANTHAPURAM

(Present : Rishi Raj Singh IPS)

**Sub.**—Excise Establishment—Seniority List of Circle Inspectors of Excise/Superintendents/Managers for the period from 1-1-2009 to 31-12-2017—Finalized and published—Orders issued.

**Read.**—(1) This Office Order No. XD2-23502/2010 dated 23-5-2011.

(2) This Office Order of even No. dated 6-1-2018.

**Order No. EXC/3/2018-XD3 dated 24-1-2019.**

The Seniority List of Circle Inspectors of Excise/Superintendents/Managers for the period from 1-6-2004 to 31-12-2008 was finalized and published vide order read 1st above. In continuation to the aforesaid seniority list, a provisional seniority list of Circle Inspectors of Excise/Superintendents/Managers for the period from 1-1-2009 to 31-12-2017 was published, as per order read 2nd above and forwarded to all sub offices to serve all concerned and called for objections, if any, to be considered before finalizing the list, within 30 (thirty) days from the date of order. The Provisional seniority list was published in the Official website of Excise Department and also sent to all sub offices through e-mail. The objections so far received have been examined in detail with relevant rules, orders and Court directions and the petitioners were heard in person on 17-9-2018 and the mistakes pointed out have been rectified.

(2) One of the objections raised against the provisional seniority list read as 2nd paper above by Sri. B. Tenymon & others was on inclusion of occurrence of vacancies arose consequent to the retirement of Sri. D. Ramachandran (Sl. No. 28) and Sri. K. P. Alexander (Sl. No. 31) as they were not included in the previous seniority list of Circle Inspectors of Excise. In the Seniority List of Circle Inspectors of Excise for the period from 1-7-2000 to 31-5-2004, Sri. P. V. Ramachandran was included as Sl. No. 86 and his name was erroneously mentioned in the order read 2nd above as D. Ramachandran and the same is corrected and included in the final list. Sri. K. P. Alexander was promoted to the cadre of Circle Inspector of Excise as per Order No. XD2-19290/07 dated 26-7-2007 and he retired from service on superannuation on 31-3-2011 as Circle Inspector of Excise. Hence, the claim of the petitioners not to include the occurrence of vacancy consequent to the retirement of Sri. K. P. Alexander in the order read 2nd above, as his name was not included in the previous seniority list of Circle Inspectors of Excise, deserves no merit and hence rejected.

(3) Another objection raised by them is on non-inclusion of occurrence of vacancies consequent to the retirement of Sri. Thomas K. Abraham, Joint Excise Commissioner (Rtd.) and promotion of S/Sri. N. S. Salimkumar and K. Muhammed Resheed, Deputy Excise Commissioners. The occurrence of vacancy of Sri. Thomas K. Abraham is included in the Provisional Seniority list as serial No. 59. Since the objection raised in respect of Sri. Thomas K. Abraham is irrelevant and hence rejected. S/Sri. N. S. Salimkumar and K. Muhammed Resheed, Deputy Excise Commissioners are now in service. Hence, the objection raised deserves no merit and rejected.

(4) In another objection filed by them, it is claimed that out of 18 Gazetted posts in the department that have to be reserved for SC/ST category, only 12 posts are occupied and 6 vacancies are to be reserved for them. During the period from 1-1-2009 to 31-12-2017, there are 194 gazetted posts in the department. Out of the 19 posts (10%) to be reserved for SC/ST category, 14 posts are occupied and 5 vacancies have been notified by Government for the appointment through Special Recruitment.

(5) They have filed another objection that as per the amendment of Kerala State and Subordinate Service Special Rules issued vide G.O. (P) No. 57/92/P&ARD dated 5-12-1992, which taken effect from 2-2-1993, 15 Directly recruited Excise Inspectors are found excess and hence the occurrence of vacancies consequent to the retirement of above said 15 Directly recruited Excise Inspectors may not be included in the Provisional Seniority list read 2nd above. The 15 Directly recruited Excise Inspectors who were found excess than the quota prescribed as per Special Rules were given assignment in the Seniority List with effect from the date on which they become eligible. Their objection therefore deserves no merit and rejected.

(6) The petitioners have also claimed that while finalizing the seniority list of Circle Inspectors of Excise for the period from 1-1-1996 to 30-6-2000, 19 vacancies were not given assignment which affected the promotion aspects of promotee Excise Inspectors. Such a claim could have been raised before finalization of the said list. After a lapse of 9 years this claim seems irrelevant and hence rejected.

(7) Sri. S. Sunil, who was advised by the Kerala Public Service Commission as Excise Inspector on 13-2-1996 has requested to reassign his seniority based on the Judgment of Hon'ble Supreme Court in Civil Appeal No. 7849/2009 and as per order dated 25-10-2017 in O.A (EKM) No. 2146/2017. As per the amendment of Kerala State and Subordinate Special Rules issued vide G.O (P) No. 57/92/P & ARD dated 5-12-1992, which taken retrospective effect from 2-2-1993, 15 Directly recruited Excise Inspectors were found excess than prescribed ratio, then. These excess posts were considered supernumerary. They have given assignment date in the Seniority List as per their turn as prescribed by the Special Rules. Hence, the request of Sri. S. Sunil, Circle Inspector of Excise, to reassign the seniority by considering Advice date as assignment is rejected. Also judgement dated 21-9-2017 of the Hon' ble Supreme Court in Civil Appeal No. 7849/2009 is in no way related to him. In compliance with the Court order dated 25-10-2017 in O. A (EKM) No. 2146/2017, the plea of the petitioner to reassign seniority of Excise Inspectors was considered and rejected vide Order No. XD3-51761/2017 dated 12-12-2017. Hence, the plea of the petitioner to reassign seniority deserves no merits and hence rejected.

(8) Sri. K.R. Ajay and others have requested that the Seniority list of the Circle Inspectors of Excise shall be finalized subject to the verdict of cases viz, T.A. No. 2083/12, O.A No. 1873/15, O.A No. 147/2014 pending before the Hon'ble Kerala Administrative Tribunal.

(9) Considering the above, the provisional Seniority list of Circle Inspectors of Excise/Superintendents/Managers for the period from 1-1-2009 to 31-12-2017 already published as per order read 2<sup>nd</sup> above is rectified and finalized subject to the final decision in T. A. No. 2083/2012, O.A. No. 1873/2015, O.A No. 147/2014 and is published herewith.
