Sub:- Excise Establishment – Seniority list of Excise Inspectors for the period from 01.04.2004 to 30.06.2006 – Modified - published - Orders issued.

The Seniority list of Excise Inspectors for the period from 01.01.2004 to 30.06.2006 was finalized vide order read 1st above. Sri. G. Krishnakumar, Excise Inspector in his representation submitted that his seniority in the said list is mistakenly placed as Sl No. 157 with 02.04.2005 as date of assignment. Actually he entered in service in the cadre of Excise Inspector on 01.12.2005 as per the advice of the Kerala State Public Service Commission vide letter No. RIA (I) 10029/04 dated.19.08.2005. Hence, he is eligible to get seniority only on 19.08.2005. On verification of the seniority list, it is found that Sri. S.K. Santhoshkumar and Sri. A.P. Shajahan, Excise Inspectors are also similarly placed in the said seniority list as Sl. No. 156 and 158 respectively with date of assignment as 02.04.2005 instead of 19.08.2005.

2) Subsequently, seniority of S/Sri. S.K. Santhoshkumar, G. Krishnakumar and A.P. Shajahan, Excise Inspectors are reassigned with effect from 19.08.2005 vide order read 2nd above as Sl. Nos. 176A, 176B and 176C respectively in between Sl. No. 176 Sri. Saji Mathai and

Sl.No. 177 Sri. P.A. Benny in the seniority list of Excise Inspectors for the period from 01.01.2004 to 30.06.2006 which was finalized vide order read 1st above, and as such Sl.No.156,157,158 in the said seniority list stands cancelled.

3) In the circumstances, the seniority list of Excise Inspectors for the period from 01.01.2004 to 30.06.2006, which was modified vide order read 2nd above is published herewith.
