In exercise of the powers conferred under section 24 of the Abkari Act, 1 of 1077, and in partial modification of the notification issued under G.O(P)No.145/2018/TD. Dated, 12<sup>th</sup> September, 2018 and published as S.R.O.No.629/2018 in the Kerala Gazette Extraordinary No.2308 dated 12<sup>th</sup> September, 2018 the Government of Kerala hereby direct that the maximum quantity on each permit to be issued under sections 6, 7 and 11 of the said Act, as 30,000 Bulk Litre to all



licensees under the Foreign Liquor Rules, 1953, the Foreign Liquor (Storage in Bond) Rules, 1961, the Brewery Rules, 1967, the Kerala Distillery and Warehouse Rules, 1968, the Kerala Winery Rules, 1970, the Kerala Rectified Spirit Rules, 1972, and the Kerala Foreign Liquor (Compounding, Blending and Bottling)Rules, 1975 for the purpose of importing, exporting or transporting any kind of liquor and rectified spirit including absolute alcohol.

## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government find it necessary to enhance the maximum quantity to be lifted on each permit to be issued under sections 6, 7 and 11 of the Abkari Act, I of 1077, from 25000 Bulk Litre to 30000 Bulk Litre, to all licences issued under the Foreign Liquor Rules, 1953, the Foreign Liquor (Storage in Bond) Rules, 1961, the Brewery Rules, 1967, the Kerala Distillery and Warehouse Rules, 1968, the Kerala Winery Rules, 1970, the Kerala Rectified Spirit Rules, 1972, and the Kerala Foreign Liquor (Compounding, Blending and Bottling) Rules, 1975 for the purpose of importing, exporting or transporting any kind of liquor and rectified spirit including absolute alcohol. For this purpose it has been decided to modify the notification issued under G.O.(P) No. 145/2018/TD. dated 12<sup>th</sup> September, 2018 and published as S.R.O. No. 629/2018 in the Kerala Gazette Extra-ordinary No.2308 dated 12<sup>th</sup> September, 2018 suitably.

The notification is intended to achieve the above object.
