PUBLIC SERVICES—REVISED QUALIFICATION FOR THE POST OF LAST GRADE SERVANTS, LOWER DIVISION CLERK, LOWER DIVISION TYPIST, TYPIST GRADE II, CONFIDENTIAL ASSISTANT GRADE II/STENO TYPIST, TYPIST-CLERK, CLERK-TYPIST AND ASSISTANT (GOVERNMENT SECRETARIAT, KERALA PUBLIC SERVICE COMMISSION, LOCAL FUND AUDIT DEPARTMENT ETC.)—PROTECTION CLAUSE FOR THE EMPLOYEES WHO ENTERED IN SERVICE BEFORE 1-7-2011—INCORPORATED—ORDERS ISSUED

ORDER

As per the Government Order read as 1st paper above, Government have modified the qualification for the post of Last Grade Servants, Lower Division Clerk, Lower Division Typist, Typist Grade II, Confidential Assistant Grade II/ Steno Typist, Typist-Clerk, Clerk-Typist and Assistant (Government Secretariat, Kerala Public Service Commission, Local Fund Audit Department etc.)

As per G.O. read as 2nd paper above, Government have ordered that the revised qualifications issued as per Government Order read as 1st paper above will be applicable only to those notifications, which are published by the Commission on or after 1-7-2011. Government have also consulted Kerala Public Service Commission as to whether a protection clause may also be incorporated in the G.O. read as 1st paper above to the effect that the revised qualifications will be made applicable for by transfer appointments only to those candidates who entered service on or after 1-7-2011. But the Commission has agreed only to exempt those employees in service who have attained the age of 50 or above as on the date of the Government Order, read as 1st paper above.

Government have examined the matter in detail and are pleased to modify the Government Order read as 1st paper above to the effect that the revised qualifications prescribed in the Government Order read as 1st paper above, are applicable only to those employees for by transfer appointments who entered Government service in the relevant category on or after 1-7-2011. The Order is issued by over ruling the advice of Kerala Public Service Commission.

The Government Order read as 1st paper above stands modified to the above extent.
