S. R. O. No. 491/2017.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968) read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Special Rules for the Kerala Excise and Prohibition Subordinate Service issued by notification under G. O. (P) No. 112/74/TD dated 9th September, 1974 and published as S.R.O. No. 689/74 in Part I of the Kerala Gazette No. 39 dated 24th September, 1974, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Excise and Prohibition Subordinate Service (Amendment) Special Rules, 2017.

(2) They shall be deemed to have come into force on 5th day of October, 2015.

2. *Amendment of the Rules.*—In the Special Rules for the Kerala Excise and Prohibition Subordinate Service, after rule 5, the following rule shall be inserted, namely:—

5A. “Notwithstanding anything contained in these rules, the qualification and other recruitment conditions prescribed as per the Kerala Excise and Prohibition Subordinate Service (Amendment) Special Rules, 2015 to categories 1, 3 and 4 shall be applicable only to fresh notification for recruitment issued by the Kerala Public Service Commission after 5th October, 2015”.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the notification issued under G. O. (P) No. 178/2015/TD dated 3rd October, 2015 and published as S.R.O. No. 669/2015 in the Kerala Gazette Extraordinary No. 2257 dated 5th October, 2015, the Government have modified the qualifications and other recruitment conditions for the categories of Excise Inspector, Civil Excise Officer/ Women Civil Excise Officer and Driver in the Excise Department with

retrospective effect. The Kerala Public Service Commission has been advising candidates for the vacancies reported with regard to the above posts from the ranked lists already existing prior to the said amendment. In order to enable the Kerala Public Service Commission to make advices from the existing ranked lists for the above posts which were prepared based on the qualifications and other recruitment conditions that existed prior to the coming into force of the said amendment, the Government have decided to incorporate a new provision in the concerned amended rules in public interest.

The notification is intended to achieve the above object.
