1. The appointment is subject to Rule 3 (C) and 9 (a) (i) of KS& SSR 1958 and is provisional.

2. Training

The candidate will have to undergo training as envisaged in Rule 9 of the Kerala Excise and Prohibitions Subordinate Service Rules issued vide G.O.(P) No.112/74/TD dated. 09/09/1974 and G.O.(P) 178/2015/TD dated 03/10/2015. The training includes physical training and practical training in various field offices and administrative

offices of the department, different Institutions and Offices of other departments like Public Prosecutors Offices, Chief Chemical Examiner's Laboratory etc. If the trainee fails to complete any item of the above training satisfactorily, he/she shall be required to undergo training in that item for a further period as decided by the Training Authorities. During the training period the trainees shall be paid stipend which has been fixed to the minimum of their basic pay (43,400) as per Government Order read as 1st paper and as per Order No. EXC/4201/2019 – XD3 dated 06/09/2019 of the Excise Commissioner.

3. Bond

The trainee should execute a bond agreeing to complete the course of training and to serve the Department for a period of five years, after completing the training failing which he / she shall be liable to refund the cost of training with damages vide Sub Rule 2 of Rule 9 of the Kerala Excise and Prohibitions Subordinate Service (Special Rules) as envisaged in Order No.XD3-3117/2016 dated 02.08.2017 (specimen copy of bond agreement enclosed. See Appendix). The candidates are directed to produce the executed bond with Government servants as sureties in Stamp Paper worth Rs.200/- at the time of joining.

4. Probation

The trainee will be on probation for a period of two years of duty within a continuous period of three years. During the probation, he/she shall have to pass Account Test (Lower), Excise Test Part A and B and MOP test conducted by Kerala Public Service Commission.

5. Documents

- a. The candidates should produce the duly filled in Annexure I at the time of joining.
- b. The candidate with serial No.1,3,5,9,12,14,15,16,18,19,21,23, 25,27,29, 32, 34 and 36 are directed to produce original Community Certificate/ Non-creamy layer certificate as required at the time of joining duty.
- c. The candidate with serial No.10,20,30 and 40 are directed to produce the Original Service Certificate at the time of joining duty
- d. The Candidates should produce original documents to prove their age, educational qualifications and conduct certificate.
- e. The Candidates should produce certificate showing their physical fitness and capacity to do outdoor works obtained from the Medical Officer not below the rank of a Civil Surgeon at the time of joining duty.
- f. The Candidates should produce the original Advice Memo issued to the Candidate from the Kerala Public Service Commission, at the time of joining duty.

The Candidates are directed to report before the Director, State Excise Academy & Research Centre, Poothole, (Near Railway Station), Thrissur on **27/05/2024 at 10.00 AM** failing which the Kerala Public Service Commission will be requested to cancel the advice.

The Director, State Excise Academy & Research Centre, Thrissur, will issue a training schedule to the candidates.
