Sub: Excise Establishment - Notional Promotion of Excise Inspectors to the combined cadre of Circle Inspectors/ Managers/ Superintendents of Excise - Orders issued.

ORDER No.EXC/3318/2024-XD3-Part(3) Dated.06-12-2024

The seniority list of Excise Inspectors for the period from 01.07.2006 to 30.04.2019 has been recast and published as per Order read 13th above. The Adhoc Departmental Promotion Committee (Lower) in Excise Department, which met on 28.11.2024, has revised the Select Lists of Excise Inspectors for promotion to the combined cadre of Circle Inspectors/ Managers/ Superintendents of Excise for the years 2019 (Supplementary), 2020, 2021 & 2022, and prepared the Select Lists for the years 2023 & 2024, in accordance with the changes made in the recast feeder category seniority list of Excise Inspectors. The revised Select List has been prepared as per Order read 15th above and the same has been approved by Government as per letter read 17th above.

As per Orders read 1 to 10 above, 90 numbers of individuals included in Table- 1 have been given regular promotions to the cadre of Circle Inspectors/ Managers/ Superintendents of Excise. Since their seniority in the cadre of Excise Inspector and also their positions in the select list have been reassigned due to recast of the seniority list, they are to be given notional promotion as per their revised seniority in the recast seniority list of Excise Inspectors and also the revised select list.

As per Orders read 11 and 12 above, 42 numbers of individuals included in Table- 2 have been given temporary promotion to the cadre of Circle Inspectors/ Managers/ Superintendents of Excise under Rule 31(a) (i) of KS&SSR. They need to be given notional promotion as per their revised seniority in the recast seniority list of Excise Inspectors and select list (except Sl No. 26). Sri Sreedharan.A, Sl No. 26 in Table- 2, (PEN: 699672, Sl No. 356 in recast seniority list of Excise Inspectors, Sl No. 12 in the select list for 2023) has been selected provisionally by the DPC(L) dated 28-11-2024 since he is having memo of charges for minor punishment pending against him. Hence he is eligible only for provisional promotion.

15 (Fifteen) vacancies are available in the cadre of Circle Inspectors/ Managers/ Superintendents of Excise as on the date of this order. Sri Venu.P.P, Sl No. 481 among the recast seniority list of Excise Inspectors for the

period from 01-07-2006 to 30-04-2019 (Sl No. 01 in the select list for the year 2024), is eligible for notional promotion to the cadre of Circle Inspectors/ Managers/ Superintendents of Excise as on 05-03-2024. But since he retired from service on superannuation on 31-03-2024, the occurrence of vacancy due to his retirement can be taken for granting promotion. Hence, 16 (Sixteen) Excise Inspectors included in the select list of Excise Inspectors can be given notional promotion in the order of their assigned seniorities. The names of those 16 individuals are given in Table-3.

In the above circumstances, the Officers included in Table-1, Table-2 and Table-3 (except Sreedharan.A, Sl No. 26 in Table-2) are hereby given notional promotion to the combined cadre of Circle Inspectors/ Managers/ Superintendents of Excise subject to Rule 23 (c) of Volume 1, Part 1 of Kerala Service Rules. The date of notional promotion shall be the date included in column- 6 of Table 1, Table 2 and Table 3 against the names of the respective individuals.

The notional promotion to the combined cadre of Circle Inspectors/Managers/ Superintendents of Excise granted to Sri Sreedharan.A, Sl No. 26 in Table- 2 (PEN: 699672, Sl No. 356 in recast seniority list of Excise Inspectors, Sl No. 12 in the select list for 2023) shall be provisional under Rule 28(b) (i)(7) Note (i) of Kerala State and Subordinate Service Rules 1958. The regularization of this provisional promotion shall be subject to the decision of the Departmental Promotion Committee (Lower) to be convened in this regard later.
